### Objective:

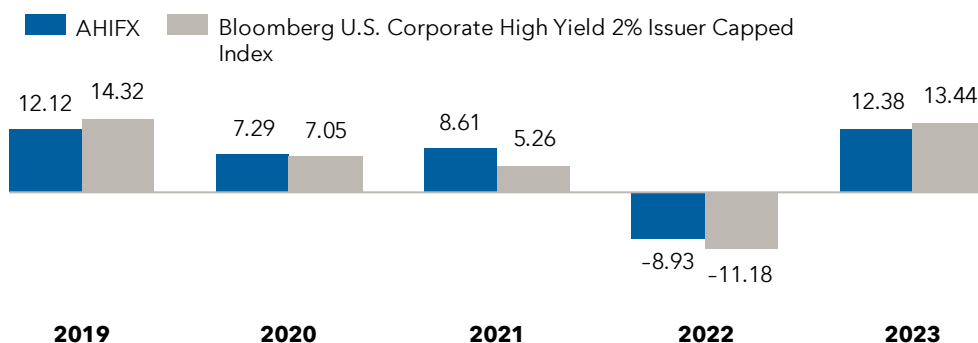
The fund's primary investment objective is to provide you with a high level of current income. Its secondary investment objective is capital appreciation.
