Distinguishing characteristics:

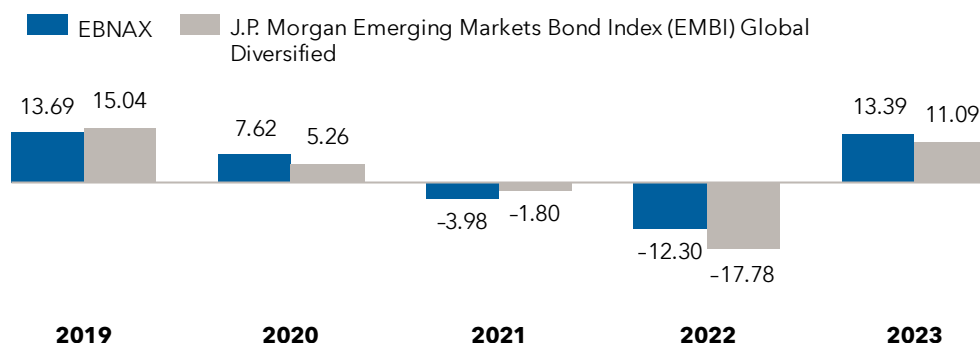
